What is Dual Enrollment?

- The Dual Enrollment program is an opportunity for qualified high school students to earn college credits.
- The student is concurrently enrolled in high school and in college.
- The student can be a full time or part time college student.
- The student earns college credits as well as high school credits needed for graduation.



Who is eligible to participate?

- 11th & 12th graders who are **college ready**
 - 10th graders are only eligible to take CTAE electives at technical colleges (TCSG); most colleges do not accept 10th graders
- No residency or citizenship requirement
- Must meet postsecondary admission requirements
- Cannot have already met graduation requirements at the start of the school year



What are the Benefits??

- Free head start on college-Dual Enrollment covers tuition, books & mandatory fees
- Access to a variety of advanced curriculum
- Provides flexibility with scheduling
- Helps students with the transition to college from high school
- Opportunity to investigate and pursue career goals
- DE does not cut into credit hours for the HOPE Scholarship
- Attendance during fall, spring and summer is possible; full time or part-time
- Students may still remain connected to SKG through extracurricular and other activities

Things Current Students Like Most About Dual Enrollment

- Independence & freedom
- Freedom to pick schedule/flexibility of classes
- Getting ahead with college credits
- College experience
- Sleeping in
- Ability to work ahead
- Weekly assignment options instead of daily



Some Challenging Issues...

- Communication w/professors; not always easy to reach
- Grade determined by 3 tests/essays or low amount of assignments
- Time management; keeping up w/workload
- Breaks are not the same as GCPS
- Procrastination—students work at own pace
- Classes move quickly—must study more



Some Challenging Issues...

- Navigating online platforms, course expectations, textbooks, etc.
- Some professors are not as understanding as SKG teachers
- Professors don't tell you exactly what to study for
–must study consistently and take good notes
- Possibly taking classes outside of SKG hours





Ways to participate in DE

Part-Time

- Take a combination of classes at SKG and the college
- **Minimum 6 classes are taken between the college and SKG** (ex. 3 at college & 3 at SKG)
- Plan college classes and class times around the courses student selected to take at SKG
- If taking an online DE course, students may opt to work in our lab on campus for a class period

Full-Time

- Attend classes at the college full-time; No classes at SKG
- Minimum of 4 classes at the college for both semesters
- Take up to 15 semester hours
- Still considered SKG student
- Must earn 2.5 credits per semester in order to be eligible for participation in athletics

House Bill 444

- A **total of 30 DE credit hours** will be funded by the state. Any additional credits are self-pay.
- The state will not pay for a student to retake a class.
- If a student **withdraws from 2 courses or fails 2 courses**, they will not be eligible to continue in the DE program.
- Student must maintain "Satisfactory Academic Progress" at the college – **can be denied participation for violation of college rules or academic progress.**





Considerations for DEE

- **Students must have transportation** to & from the college (if applicable); must factor in travel time, parking, traffic, bell schedules, etc.
- **College and high school breaks/holidays often do not align.**
- **College attendance policies are strict:** absences may not be excused due to state play-offs, family vacation, etc.
- **DE courses start a student's college GPA and transcript!**
- Student may be in classes with adults and be the youngest in the room.
- SKG announcements or information could be missed; **students must check in with the SKG website/senior page for important information.**



Considerations for DEE

- Student services (504 Plans, IEP, etc.) must be arranged with the college by the student. Please speak to your case manager prior to enrolling in dual enrollment courses. Accommodations given at the college could be different than ones given at SKG.
- Students may be assigned to a lab period if working on an online DE course, and attendance is required. (Students w/o their own transportation)
- If not in a DE Lab, students are not allowed to be on SKG's campus on days or periods they don't have their college classes. Students can't hang out in the media center, collaboration space, etc.



A Few More Things to Consider:

- Colleges **communicate with the student**—not the parent or with SKG.
- Students **must be able to handle all college responsibilities** on their own.
- Final grades are sent at the **end of the semester**—SKG and parents may not know about failing grades until the end of the semester.
- Competitive colleges may not consider dual enrollment courses as rigorous as Advanced Placement courses.
- Credit transferability is **not** guaranteed.
- Some course specific fees must be covered by the student.

How does grading work?

- Letter grades from the college will be transcribed as:
 - **A=95 B=85 C=75 D=70 F=55**
- ALL DE grades are included on the high school transcript – including F's and withdrawals. (w=z)
- 3+ credit hours = 1 Carnegie unit
- 1-2 credit hours=0.5 Carnegie unit (Science labs do not earn high school credit)
- Additional points are NOT added to the college grade on the high school transcript w/ the exception of Georgia Tech math and computer science courses.
- Students receive a .5 GPA boost for DE courses on their HOPE transcript.
- College classes are one semester long, NOT the entire year.
Your DE schedule will need to be updated each semester.





How do DE and AP classes compare?

Both options allow the opportunity to earn college credit and demonstrate rigor/challenge. Differences include:

Advanced Placement

- Classes taken at the local school, taught by HS teachers
- Students can choose to take AP exams at a cost
- College credit is awarded based on performance on the AP exam
- Recognized nationally by colleges and universities
- 10 points added to final grade in the course

Dual Enrollment

- Taught on the college campus by college instructors
- Classes can be taken face-to-face or online
- Grades of C or better transfer to most colleges within Georgia and to some (not all) out of state colleges
- 10 points not added to the final grade unless upper level math or computer science at GA Tech.



Transferring Dual Enrollment Credits



It is the **student's responsibility** to verify with colleges regarding their policies on accepting transfer credit and how the credit will be used (elective vs credits for major).

The counselor is responsible for advising on courses needed for graduation.

Students who are looking to attend private or out-of-state colleges & universities need to speak to those colleges to determine what is accepted.

Dropping or Changing Courses

- **Classes may NOT be dropped after the college's drop/add period.**
 - If a student withdraws from a class, this will be reported as a "Z" on your transcript.
 - This action could delay graduation plans.
 - If W/D, students are required to return to SKG to take the class.
 - If a student W/D from a class without informing counselor and DE Coordinator, they will **not** be able to continue in the DE program for the next semester.





Is Dual Enrollment right for me?

Considerations – Are you or is your student...



- Disorganized or Organized?
- Reactive or Proactive?
- Rigid or Flexible?
- Easily Overwhelmed or Able To Handle Stress?
- Unassertive or Assertive?
- Unwilling/Unable to Ask for Help or Can/Able to Self-Advocate?
- A Procrastinator or On Top of Things?
- Highly Dependent on Parents or Independent?
- One Who Ignores Emails or Checks & Responds Right Away?

Student Responsibilities



Colleges will only communicate with the student –not the parent/guardian or with SKG Staff.

Students must be able to handle all college responsibilities **independently.**

While participating in DE, students will be expected to follow the course syllabus –this includes navigating through different online platforms for their college classes. Course requirements and expectations will vary from course to course.

Parents, think of this as the time for your student to “sit in the driver’s seat” of their college journey. You can be there providing direction and support, but **allow your student to “drive the car.”**

What are the next steps?

February Registration Process at SKG

When you register for classes in February, select **seven classes at SKG** that you plan to take.

Once you are accepted into the college and register for your DE classes, we will adjust your SKG schedule accordingly (probably July).

- ❑ Submit transcript to the college through GAfutures.org (**SSN must be on file at SKG for this option to be available.**)

After being accepted to the college...

- ❑ Schedule an appointment in the month of March to meet with your assigned counselor to confirm the courses needed for graduation.
- ❑ Return the SKG Dual Enrollment Contract signed by student and parent/guardian by April 1, 2025 (to Counseling Canopy)
- ❑ Make a registration or orientation appointment at the college.
- ❑ Register for college classes – follow college procedures for registration.
- ❑ Confirm your SKG schedule with your counselor before the start of each semester. (Summer-end of April, Fall-end of July, Spring-end of November)
- ❑ Submit a copy of your college schedule to your counselor. This must be done every semester.
- ❑ Part-time DE students will need to make transportation arrangements.



Deadlines

Students must complete all paperwork & apply to the college for Dual Enrollment by the following dates:

Fall 2025 or Summer 2025 Deadline – April 1, 2025

Spring 2026 Deadline – November 5, 2025

College deadlines could be earlier or later, but students **must** meet SKG's deadline to participate.

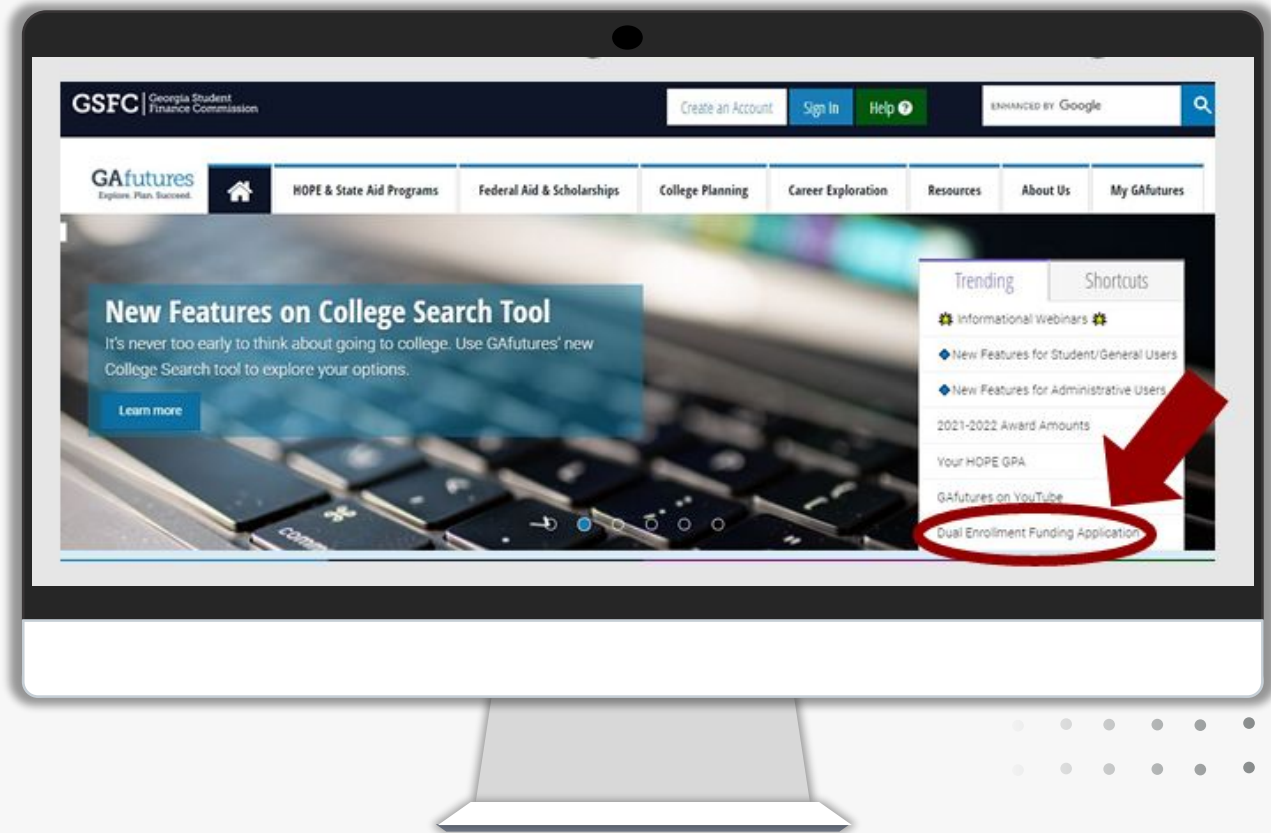

- Part of the University System of Georgia
- Most **ethnically diverse** Southern regional college

WHO QUALIFIES FOR DUAL ENROLLMENT AT GGC

- By the first day of semester at GGC:
- must be 16 years of age
- must be an 11th or 12th grade student
- Be on-track for completing all high school graduation requirements
- Be on-track for completing the USG's Required High School Curriculum (RHSC)
- Have a 3.25 High School GPA as calculated by GGC Admissions on the RHSC courses completed
- Meet all other dual enrollment admission requirements
- Meet GSFC's Dual Enrollment funding Program eligibility (details on GAfutures site: gafutures.org)

TEST SCORES

GGC is test-optional for admission into the dual enrollment program. However, SAT/ACT or ACCUPLACER exams might be needed for placement purposes.

- Dual Enrollment students may only enroll in an English or mathematics course if they exempt placement in corequisite Learning Support.
- Meaning, it is possible to be accepted but not place into a math or English course.
- For course placement purposes, limit of two Next Generation ACCUPLACER exam attempts per academic year

HOW AND WHEN DO I APPLY?

1. Create Grizzly Profile to Apply Online, Dual Enrollment Students are exempted from application fee- watch for a pop-up in your browser window
2. Review Admission Requirements
3. Submit Document Requirements
4. Meet with your high school counselor so they can begin the approval process on the high school side.
5. Once accepted, register for an orientation where you will be advised and register for your classes

All application materials must be submitted by the dates below for each semester.

- Spring Semester, priority – Nov. 1
- Summer semester, priority – April 1
- Fall Semester, priority – May 1

STANDARDS OF ACADEMIC PROGRESS

A Dual Enrollment student must maintain a 2.50 or higher post-secondary GPA and complete 67% of all attempted classes to remain in good academic standing.

A student who earns a 2.0 to 2.49 overall GPA at the end of a semester will have one semester to raise their overall GPA to a 2.50. Failure to earn an overall GPA of 2.50 or higher will result in dismissal from the UNG Dual Enrollment program.

A student who earns below a 2.0 overall GPA at the end of a semester will be immediately dismissed from the Dual Enrollment program.

Dual Enrollment courses result in real college credit and the grades become a part of the student's permanent college record. Grades earned through Dual Enrollment could impact future eligibility for college admission and scholarships as well as high school graduation.

TIPS FOR STUDENT SUCCESS



- Communicate proactively
- Ask for help/Use college resources
- Prioritize collegiate work
- Turn in assignments on time
- Follow-up and follow through with instructions and recommendations



ADMISSIONS REQUIREMENTS



- Student must be entering junior or senior year of high school.
- Student must present a cumulative grade point average (GPA) of 3.25 or higher, and the transcript must show evidence that the student is on track toward the completion of the USG RHSC requirements and high school graduation.
- The student must meet the subsection minimum requirements for a single test type.
 - **UNG accepts:** SAT, ACT, PSAT, PreACT, Accuplacer

APPLICATION PROCESS

1 Apply for admission through GA Futures

The application fee is waived for all DE applicants.

2 Request High School Transcript

UNG Admissions must receive a copy of your transcript in a sealed envelope directly from the school or electronically through GA Futures.

3 Submit official test scores

Acceptable test formats: SAT, ACT, Accuplacer, pSAT, PreACT.

4 Submit proof of lawful presence

5 Complete GAfutures funding application

Separate application is required to obtain funding for DE courses.

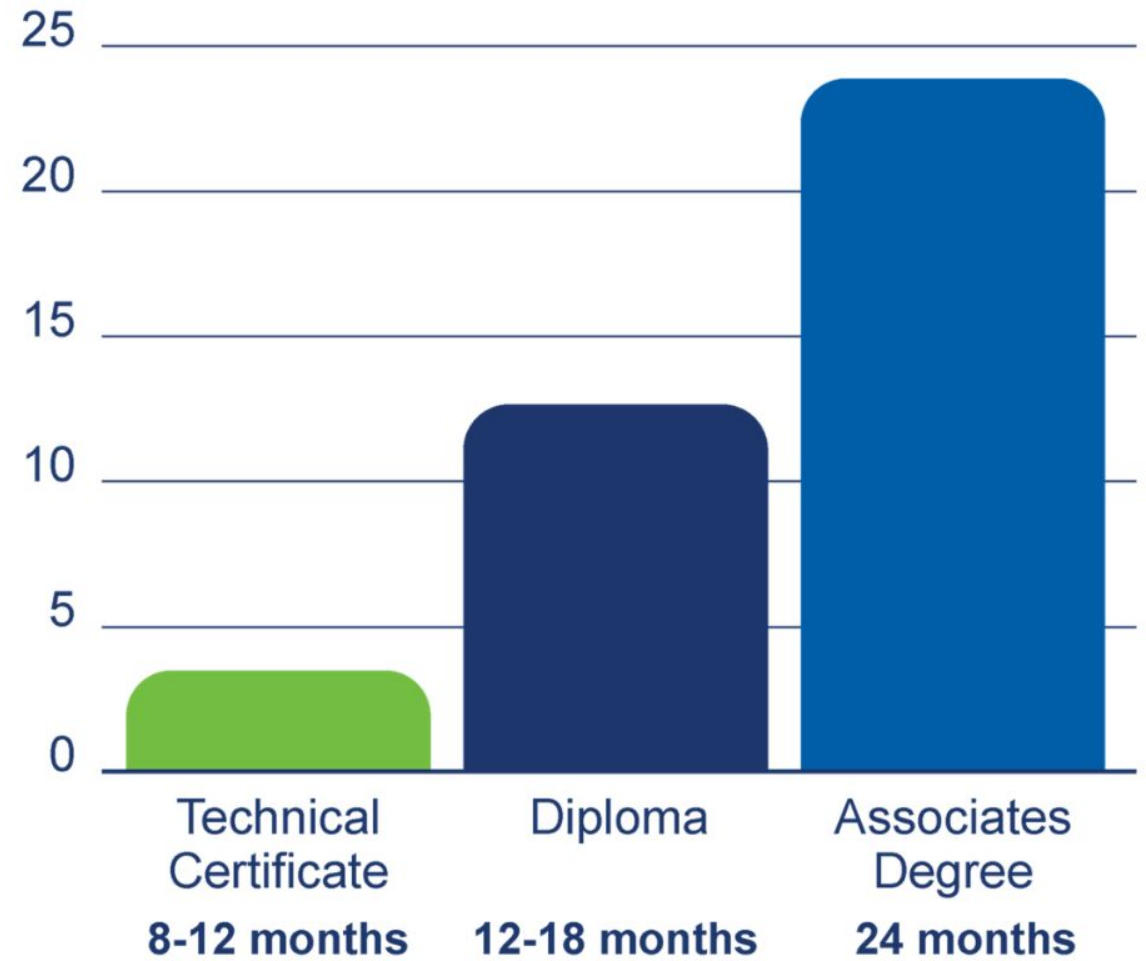

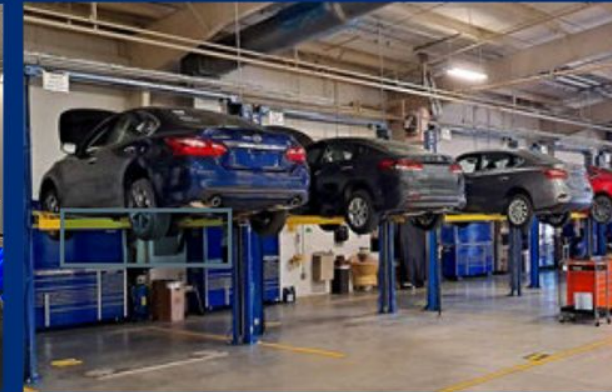

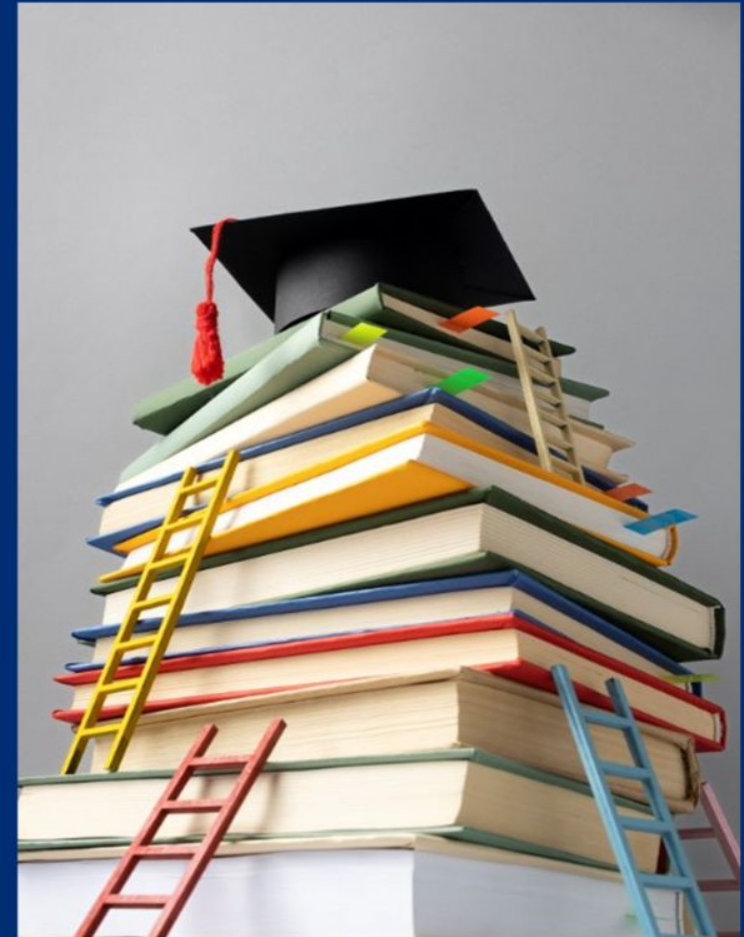

- Complete the GA Futures Dual Enrollment Funding Application
- Submit academic transcript or Placement Test Scores
 - Degree – 2.6 GPA
 - Diploma/Certificate – 2.0 GPA
